REFERENDUM

DENMARK SCHOOL DISTRICT

Question Number 1: Shall the School District of Denmark, Brown, Manitowoc and Kewaunee Counties, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$14,900,000 for the public purpose of paying the cost of a school improvement program at District buildings and grounds consisting of: remodeling and renovations for a new gymnasium and updating the cafeteria and auditorium; upgrading and enhancing agriculture science and technical education areas; maintenance site improvements; and acquisition of furnishings, fixtures and equipment?

Question Number 2: Shall the School District of Denmark, Brown, Manitowoc and Kewaunee Counties, Wisconsin be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$925,000 a year beginning with the 2017-2018 school year and ending with the 2019-2020 school year, for non-recurring purposes consisting of operating expenses, including ongoing educational programming and maintenance, enhancing safety and security, transportation and technology?
