

JUNE 14, 2018

Meeting called to order at 5:08 p.m. Peterik, Sortwell, Nehring and Herman present.

Building, Zoning & Culvert Permits – Motion by Sortwell, second by Nehring, to refund \$600.00 to Mike Pekarek, representing unnecessary inspection packet payment. All voting aye, motion carried.

Town Board Reports – Nehring and Sortwell reported on calls regarding brush cutting.

Road Projects – Various – Peterik met with Kossuth on Fisherville Road – French drains will be installed by Lambert. Peterik stated extensions need to be added on Horse Road emergency work done. Clerk will locate documents regarding Lover’s Lane to give history of events to Sortwell and Nehring.

Road Work – Budgeting – figures were reviewed for future road work projects. Motion by Sortwell, second by Nehring, that \$50,000.00 certificate of deposit at Bank First National be devoted for Old Y Bridge replacement representing 2018 and 2019 designations of \$25,000.00 each. All voting aye, motion carried.

Culvert Replacement – Twin Bridge overflow culvert will be replaced now by county – barricades up.

Culvert Mapping – matter will be further researched and discussed at future meeting.

Grass Cutting/Brush Cutting – Peterik met with Felde/O’Connor regarding brush cutting at intersection of Old Y/Lover’s Lane. Mark Cretton will cut at cost of Felde/O’Connor. Stop sign at intersection will be moved. Board states brush cutting done to date by Wendt is part of 2018 contracted amount with Wendt. Peterik states work not completed yet – about 80% complete. Motion by Nehring, second by Sortwell, to pay Shaun Wendt \$9,000.00 to cover his costs/fuel for 3 weeks work for brush cutting under contract. All voting aye, motion carried. Reported incident regarding falling brush onto car near Hermit’s Hideaway has been taken care of by Wendt.

Flooding & Road Damage – culvert installed for Zelinski access on Lovers Lane. Peterik donated culvert/Bielinski installed. Repairs are caught up for damaged roads.

Old Y Bridge Update – cost estimate received from county - \$357,000, which is eligible for bridge aid from county. Construction would begin in 2021.

Motion by Sortwell, second by Nehring, to approve renewal Operator’s Permit for Amber Engeldinger. All voting aye, motion carried.

Motion by Sortwell, second by Nehring, to pay presented bills. All voting aye, motion carried. Checks were then written from 15925 to 15931.

Motion by Nehring, second by Sortwell, to adjourn. All voting aye, motion carried. Meeting adjourned at 6:08 p.m.
